Subject: **PROVISION OF INFORMATION REGARDING DUAL NATIONALITY OF GOVERNMENT SERVANTS TO HONORABLE SUPREME COURT OF PAKISTAN**


Further to this Division's OM of even number dated 15.02.2018, the undersigned is directed to say that the Hon'ble Supreme Court of Pakistan has directed that detailed information as per attached proforma shall be collected in respect of all Cadre/Ex-cadre/Regular/Contract Government Servants (BS-17 & above) and the same may be uploaded on NADRA web-portal within a period of six days.

2. NADRA for this purpose will develop a web portal in next two days and will provide login and password to respective Heads of the Ministries / Divisions / Departments etc. and to Service Administrators for the purpose of uploading the same. It may be ensured that the Service Administrators of the regularly constituted occupational groups are required to upload the information separately for which a specific login and password will be provided. The proforma is attached as Annexure.

3. The respective heads in each case shall ensure collection of this information and uploading on NADRA web-portal at their own end within the above time line, in respect of officers under the administrative control of the Provinces, Federal Government Organisations, Ministries/Division, Autonomous Bodies and Public Limited Companies etc.

4. It may be noted that web link for downloading the requisite proforma, is available on Establishment Division's official website (www.establishment.gov.pk) as well.

5. The information provided to this Division or uploaded on NADRA web-portal shall be treated as statement on Oath. Any mis-declaration shall be subject to penalty under the law.
