
OFFICE MEMORANDUM

Subject: - GRANT OF NO OBJECTION CERTIFICATE FOR RECRUITMENT- HQS FRONTIER CORPS KP (SOUTH), D.I.KHAN.

The undersigned is directed to refer to M/o Interior's O.M. F. No. 3/1/2018-FC(KP) SOUTH dated 03<sup>rd</sup> February, 2021 on the subject noted above and to state that obtaining a prior NOC from this Division is mandatory before making specified kind of recruitment. Moreover, requisite staff with matching qualification, experience and grade is not available in Surplus Pool for posting against reported vacant posts. Therefore, Ministry of Interior, may fill 1712 x vacant posts (01 x Stenotypist (BPS-14), 1030 x General Duty Sepoy (BPS-05), 50 x Electrical & Mechanical Engineering (Sepoy) (BPS-05), 43 x Nursing Sepoy (BPS-05), 37 x Soldier Clerk (BPS-05), 53 x Animal Transportation Sepoy (BPS-05), 81 x Cook Sepoy (BPS-05), 278 x Non Combat Service (Enrollment) (BPS-02-06), 210 x Work Staff (BPS- 02-06) in HQs Frontier Corps KP (South), D.I. Khan an attached department under that Ministry as mentioned in the OM under reference in accordance with the approved recruitment rules of the posts subject to completion of all codal formalities and in line with the directions of this Division's Recruitment Policy dated 22-10-2014 as amended from time to time and mechanism dated 16-01-2015, as amended from time to time.

2. This NOC is valid for a period of six (06) months from the date of its issuance. However, according to para 1-(xiii) of recruitment policy guidelines dated 22-10-2014, as amended from time to time recruitment is required to be finalized **within 120 days** from the date of advertisement.

3. The advertisement to be published for recruitment may be forwarded by the concerned Ministry / Division directly to: Press Information Department, Information & Broadcasting Division. However, the appointing authority of the concerned Ministry / Division / Department / Organization shall ensure completion of all procedural and codal requirements in letter & spirit in line with the Recruitment Policy while making recruitment and will be held responsible for illegality if any.
