NOTIFICATION
Rawalpindi, the 14th January, 1988

S.R.O. 9 (KE)/88:

In pursuance of sub-rule (2) of rule 3 of the Civil Servants (appointment Promotion and Transfer) Rules, 1973, the following method, qualifications and other conditions are laid down for appointment to the post of Assistant Librarian (BS-16) in the Establishment Division:-

2. **Method of Appointment:-** The post of Assist Librarian (BPS-16) shall be filled by initial appointments and failing that by transfer.
3. **Qualification, Experience and Age limits for Initial appointment, -** A candidate must possess the educational qualifications and experience and must be within the age-limit as mentioned against the post concerned in the Schedule to this notification.

Provided that the maximum age-limit will be relaxed 3 years in the case of candidates belonging to Scheduled Castes, Buddhist Community, recognized tribes of the tribal Areas, Azad Kashmir and Northern Areas (Districts of Gilgit, Skardu and Diamir) in accordance with the institutions issued by the Establishment Division.

Provided further that for Government Servants, who have completed at least 2 years continuous Government Service maximum age limit may be relaxed by not more than 10 years up to the age of 55 years, wherever applicable.

4. **Qualifications/Conditions for Transfer---** Appointment by transfer shall be made from amongst persons holding appointment under the Federal Government on a regular basis in the same B.P.S. in which the post to be filled exists, provided the person concerned possesses the qualification/ experience prescribed for initial appointment to the concerned.

5. **Probation.** Persons appointed by initial appointment or transfer shall be on probation for a period of one year. This period may be curtailed for good and sufficient reasons to be recorded or if considered necessary, it may be extended for a period not exceeding one year as may be prescribed at the time of Section 6 of the Civil Servants Act, 1973

6. This Notification issues with the concurrence of the Establishment Division, vide u.o. No. 7/3/87-R.5, dated 7th January, 1988 and FPSC, vide their letter No. F.12-26/87-S, dated 15th December, 1987, and supersedes Establishment Division's Notification No. 1/2/86-Admn-II, dated 16th October, 1986.
