OFFICE MEMORANDUM

Subject: - RECRUITMENT IN PAKISTAN RANGERS (SINDH) AGAINST VACANT POSTS.

The undersigned is directed to refer to M/o Interior's O.M No.1/20/2014-R (Sindh) dated 27th June, 2022 on the aforementioned subject and to state that obtaining a prior NOC from this Division is mandatory before making specified kind of recruitment. Moreover, requisite staff with matching qualification, experience and grade is not available in the Surplus Pool for absorption against the reported vacant posts. Therefore, Ministry of Interior, may fill 1100 x vacant posts (19 x Sub Inspector General Duty (Direct Entrant) (BPS-13), 01 x Religious Teacher (Direct Entrant) (BPS-11), 20 x Havildar General Duty (Direct Entrant) (BPS-08), 39 x Sepoy Clerk (BPS-08), 25 x Naik General Duty (Direct Entrant) (BPS-07), 797 x Sepoy (General Duty) (BPS-05), 64 x Sepoy (Cook) (BPS-05), 11 x Sepoy Mess Waiter (BPS-05), 09 x Sepoy Misalchi (BPS-05), 115 x Non-Combatant Enrolled (NCsE) (BPS-02) in Pakistan Ranger (Sindh) an attached department of that Ministry as mentioned in the OM under reference in accordance with the approved recruitment rules of the posts subject to completion of all codal formalities and in line with the directions of this Division's Recruitment Policy dated 22-10-2014 as amended from time to time and mechanism dated 16-01-2015, as amended from time to time.

2. This NOC is valid for a period of six (06) months from the date of its issuance. However, according to para 1-(xiii) of recruitment policy guidelines dated 22-10-2014, as amended on 21-09-2017 & 04-03-2019 recruitment is required to be finalized within 120 days from the date of advertisement.

3. The advertisement to be published for recruitment may be forwarded by the concerned Ministry / Division directly to Press Information Department, Information & Broadcasting Division. However, the appointing authority of the concerned Ministry / Division / Department / Organization shall ensure completion of all procedural and codal requirements in letter & spirit in line with the Recruitment Policy while making recruitment and will be held responsible for illegality if any.
