OFFICE MEMORANDUM

Subject: - FOREIGN NATIONAL SECURITY CELL DASHBOARD AND ALLIED FACILITIES

The undersigned is directed to refer to National Crisis Information Management Cell M/o Interior's O.M No. 11/11/2021-NCIMC(Tech) dated 22<sup>nd</sup> July, 2022 on the subject noted above and to state that National Crisis Information Management Cell M/o Interior may fill 41 x project / contract posts of different cadres ranging from PPS-1 to PPS-8 i.e. 02 x Network Administrator / System Administrator (PPS-8), 02 x Data Specialist (PPS-7), 02 x Hardware Engineer / System Engineer / System Administrator / Assistant Administrator (PPS-7/BPS-17), 02 x Inspector (PPS-6/BPS-16), 14 x Computer Operator (PPS-6/BPS-16), 08 x DEO / UDC (PPS-4/BPS-11), 01 x Electrician (PPS-1/BPS-1-4), 02 x Driver (PPS-1/BPS-1-4), 02 x Janitor / Sweeper (PPS-1/BPS-1-4) and 06 x Naib Qasid (PPS-1/BPS-1-4) in National Crisis Information Management Cell under that Ministry as mentioned in the OM under reference in accordance with the approved recruitment rules of the posts subject to completion of all codal formalities and in line with the directions of this Division's Recruitment Policy dated 22-10-2014 as amended from time to time and mechanism dated 16-01-2015, 03-03-2015, 11-5-2017 & 18-8-2017.

2. This NOC is valid for a period of six (06) months from its issuance. However, according to para 1-(xiii) of recruitment policy guidelines dated 22-10-2014, as amended from time to time recruitment is required to be finalized within 120 days from the date of advertisement. Whereas in line with para-1 (xvii) of the policy guidelines, advertisement to be published for recruitment may be submitted by the concerned Ministry/ Division/ Department/Organization direct to press advertisement (PID) for publication.

3. The advertisement to be published for recruitment may be forwarded by the concerned Ministry/Division directly to Press Information Department, Information & Broadcasting Division. However, the appointing authority of the concerned Ministry/Division/Department/Organization shall ensure completion of all procedural and codal requirements in letter & spirit in line with the Recruitment Policy while making recruitment and will be held responsible for illegality if any.
