
Subject: - NOC FOR RECRUITMENT AGAINST VACANT POSTS BS-01 TO BS-15 IN THE MINISTRY OF PLANNING DEVELOPMENT & SPECIAL INITIATIVES.

The undersigned is directed to refer to M/o Planning Development and Special Initiatives O.M. No. 6(178)HRM-VI/PD/2022 dated 7th November, 2022, on the subject noted above and to state that obtaining a prior NOC from this Division is mandatory before making prescribed kind of recruitment. Moreover, surplus employees with matching qualification, experience and grade are not available in Surplus Pool for posting against reported vacant posts. Therefore, M/o Planning Development & Special Initiatives may fill 69x vacant posts i.e. 09x Assistant (BPS-15), 27x Stenotypist (BPS-14), 03x Upper Division Clerk (BPS-11), 04x Lower Division Clerk (BPS-09), 02x Staff Car Driver (BPS-04), 01x Duplicate Machine Operator (BPS-04), 01x Dispatch Rider (BPS-04), 20x Naib Qasid (BPS-01), 01x Farash (BPS-01) and 01x Chowkidar (BPS-01) in that Ministry as mentioned in the O.M. under reference in accordance with the approved recruitment rules of the posts subject to completion of all codal formalities and in line with the directions of this Division's Recruitment Policy dated 22-10-2014 as amended from time to time, and mechanism dated 16-01-2015 as amended from time to time.

2. This NOC is valid for a period of six (06) months from the date of its issuance. However, according to para 1-(xiii) of recruitment policy guidelines dated 22-10-2014, as amended from time to time recruitment is required to be finalized within 120 days from the date of advertisement.

3. The advertisement to be published for recruitment may be forwarded by the concerned Ministry/Division directly to Press Information Department, Information & Broadcasting Division. However, the appointing authority of the concerned Ministry/Division/Department/Organization shall ensure completion of all procedural and codal requirements in letter & spirit in line with the Recruitment Policy while making recruitment and will be held responsible for illegality if any.

4. Furthermore, 2x NOCs issued vide Establishment Division's O.M. dated 13-10-2022 shall be treated as cancelled / withdrawn ab-initio".
