- 2. The course will be commencing from 18-09-2023 (Monday). The nominated officers may report to NIMs Karachi, Lahore, Peshawar, Islamabad and Quetta on 15-09-2023. The above nominations are subject to provision of latest Annual Medical Examination Reports to be submitted to respective NIMs.
- It is also pertinent to mention here that the course fee for each participant for split program of MCMC is Rs.230,000/- (Rupees Two Hundred and Thirty Thousand) per participant at NIMs Karachi Lahore, Peshawar, Islamabad and Quetta (10 weeks) and Rs.64,286/- (Rupees Sixty-four Thousand Two Hundred and Eighty Six) per participant (4 Weeks) for Specialized Training Institutes. The payment of course fee in respect of officers of occupational groups and Ex-cadre officers of all Ministries/ Divisions and attached departments, nominated for the course, will be made by the Establishment Division while in case of officers of the Provincial Governments and their etc.. shall be arranged by respective autonomous bodies/organizations it departments/governments etc., and payment to this effect shall be remitted to the respective Director General, NIM, through bank draft/cross cheque/pay order at the time of joining the course by the officer concerned or as early as possible.
