OFFICE MEMORANDUM

Subject: - FILLING UP OF VACANT POSTS OF JUNIOR TECHNICIANS AND SANITARY WORKER IN FEDERAL GENERAL HOSPITAL (FGH), ISLAMABAD ON REGULAR BASIS.

The undersigned is directed to refer Ministry of National Health Services, Regulations and Coordination's U.O. No. F.3-53/2015/ADMN-FGH dated 12<sup>th</sup> January, 2021 on the subject noted above and to state that to obtain prior NOC from this Division is mandatory before making specified kind of recruitment. Moreover, requisite staff with matching qualification, experience and grade is not available in the surplus pool for posting against reported vacant posts. Therefore, M/o National Health Services, Regulations and Coordination' **Federal General Hospital, Islamabad** may fill 16 x vacant posts (01 x Junior Technician Anesthesia (BPS-09), 02 x Junior Technician LAB (BPS-09), 02 x Junior Technician OT (BPS-09), 02 x Junior Technician ECG (BPS-09), 02 x Junior Technician Sterilization (BPS-09), 01 x Junior Technician Dispenser (BPS-09), 01 x Junior Technician ENT (BPS-09), 01 x Junior Technician Dresser (BPS-09), 01 x Junior Technician Physiotherapy (BPS-09), 03 x Sanitary Worker (BPS-01) in that department under that Ministry as mentioned in the U.O under reference, in accordance with the recruitment rules subject to completion of all codal formalities and in line with the directions of this Division's Recruitment Policy dated 22-10-2014 as amended from time to time and mechanism dated 16-01-2015, as amended from time to time.

2. This NOC is valid for a period of six (06) months from the date of its issuance. However, according to para 1-(xiii) of recruitment policy guidelines dated 22-10-2014, as amended as amended from time to time recruitment is required to be finalized **within 120 days** from the date of advertisement.

3. The advertisement to be published for recruitment may be forwarded by the concerned Ministry / Division directly to Press Information Department, Information & Broadcasting Division. However, the appointing authority of the concerned Ministry / Division / Department / Organization shall ensure completion of procedural and codal requirements in letter & spirit in line with the Recruitment Policy while making recruitment and will be held responsible for illegality if any.
