2. They will be relieved by respective Provincial Governments / ICT / Government of Gilgit-Baltistan **immediately** for joining Government of Balochistan.

They will serve in Government of Balochistan for an active period of 365 days excluding all types of leave, training and deputation etc. Upon completion of 365 days' active service in Government of Balochistan, they will stand relieved for joining their Provinces of allocation / ICT / Government of Gilgit-Baltistan. Government of Balochistan may, however, retain any officer beyond this prescribed period with the consent of officer and approval of Establishment Division.

4. Government of Balochistan will send monthly report regarding utilization of their services to Establishment Division.


