
OFFICE MEMORANDUM

Subject: - NOC FOR RECRUITMENT IN SPECIAL COURTS/ TRIBUNALS ACROSS THE COUNTRY WORKING UNDER ADMINISTRATIVE CONTROL OF LAW AND JUSTICE DIVISION.

The undersigned is directed to refer to Law and Justice Division's O.M No. 22(5)/2017/A-V dated 21st September & 06th October, 2020 on the subject noted above and to state that obtaining a prior NOC from this Division is mandatory before making specified kind of recruitment. Moreover, requisite staff with matching qualification, experience and grade is not available in the surplus pool for absorption against the reported vacant post. Therefore, Law and Justice Division may fill 66 x vacant posts of different cadres ranging from (BPS-01 to BPS-14) i.e. 07 x Stenotypist (BPS-14), 01 x Reader (BPS-14), 04 x Nazir (BPS-11), 05 x UDC (BPS-11), 06 x LDC (BPS-09), 01 x Baillif (BPS-05), 03 x Driver (BPS-04), 01 x Dispatch Rider (BPS-04), 01 x Baillif (BPS-03), 12 x Naib Qasid (BPS-01), 11 x Chowkider (BPS-01), 03 x Farash (BPS-01), 01 x Mali (BPS-01), 01 x Cook (BPS01), 01 x Room Bearer (BPS-01) & 08 x Sweeper/ Sanitary Worker (BPS-01) in Special Courts/ Tribunals Across the country under administrative control of Law and Justice Division as mentioned in the OM under reference in accordance with the approved recruitment rules of the posts subject to completion of all codal formalities and in line with the directions of this Division's Recruitment Policy dated 22-10-2014 as amended from time to time and mechanism dated 16-01-2015 amended from time to time.

2. This NOC is valid for a period of six (06) months from the date of its issuance. However, according to para 1-(xiii) of recruitment policy guidelines dated 22-10-2014, as amended from time to time recruitment is required to be finalized within 120 days from the date of advertisement.

3. The advertisement to be published for recruitment may be forwarded by the concerned Ministry/Division directly to Press Information Department, Information & Broadcasting Division. However, the appointing authority of the concerned Ministry/Division/Department/Organization shall ensure completion of all procedural and codal requirements in letter & spirit in line with the Recruitment Policy while making recruitment and will be held responsible for illegality if any.
