
Subject: - RECRUITMENT IN CUSTOMS DEPARTMENT (BS-15) AND BELOW.

The undersigned is directed to refer to Directorate of Training & Research (Customs), Islamabad letter F.No. 3(172)/Admn-TR/2019 dated 13<sup>th</sup> October, 2020 on the subject noted above and to state that to obtain prior NOC from this Division is mandatory before making any kind of recruitment. Moreover, requisite staff with matching qualification, experience and grade is not available in the Surplus Pool for absorption against the reported vacant posts. Therefore, Directorate of Training & Research (Customs), Islamabad may fill 667 x vacant posts of different cadres (19 x Stenotypist (BS-14), 08 x UDC (BS-11), 566 x Sepoy (BS-05), 05 x Farash (BS-01), 13 x LDC (BS-09), 08 x Data Entry Operator (BS-12), 01 x Daftry (BS-02), 06 x Naib Qasid (BS-01), 09 x Sweeper / Sanitary Worker (BS-01), 29 x Motorcar Driver (BS-04) 03 x Mali (BS-01) in various field formations of Pakistan Customs Department under Federal Board of Revenue as mentioned at in the OM under reference in accordance with the recruitment rules subject to completion of all codal formalities and in line with the directions of this Division's Recruitment Policy dated 22-10-2014. as amended from time to time and mechanism dated 16-01-2015, as amended from time to time.

2. This NOC extends already issued NOC given vide O.M dated 23<sup>rd</sup> July, 2019 for further period of six (06) months 23-01-2020 to 22-07-2020. However, according to para 1-(xiii) of recruitment policy guidelines dated 22-10-2014, as amended from time to time recruitment is required to be finalized within 120 days from the date of advertisement.

3. The advertisement to be published for recruitment may be forwarded by the concerned Ministry / Division directly to Press Information Department, Information & Broadcasting Division. However, the appointing authority of the concerned Ministry / Division / Department / Organization shall ensure completion of all procedural and codal requirements in letter & spirit in line with the Recruitment Policy while making recruitment and will be held responsible for illegality if any.
