This NOC is valid for a period of six (06) months from the date of its issuance. 1-(xiii) of recruitment policy guidelines according to para 22-10-2014, as amended on 21-9-2017, 27-12-2018 & 04-3-2019 recruitment is required to be finalized within 120 days from the date of advertisement. Whereas in line with para-1 (xvii) of the policy guidelines, advertisement to be published for recruitment may be submitted by the concerned Ministry/ Division/ Department/Organization direct to press advertisement (PID) for publication.
- The advertisement to be published for recruitment may be forwarded by the 3. concerned Ministry/Division directly to Press Information Department, Information & Broadcasting Division. However, the appointing authority the Ministry/Division/Department/Organization shall ensure completion of all procedural and codal requirements in letter & spirit in line with the Recruitment Policy while making recruitment and will be held responsible for illegality if any.
