2. This NOC is valid for a period of six (06) months from the date of its issuance. However, according to para 1-(xiii) of recruitment policy guidelines dated 22-10-2014, as amended from time to time recruitment is required to be finalized within 120 days from the date of advertisement. Whereas in line with para-1 (xvii) of the policy guidelines, advertisement to be published for recruitment may be submitted by the concerned Ministry / Division /Department / Organization direct to Press Information Department (PID) for publication.

3. <u>The advertisement to be published for recruitment may be forwarded by the concerned</u> <u>Ministry / Division directly to Press Information Department. Information & Broadcasting Division.</u> <u>However, the appointing authority of the concerned Ministry / Division / Department / Organization</u> <u>shall ensure completion of procedural and codal requirements in letter & spirit in line with the</u> <u>Recruitment Policy while making recruitment and will be held responsible for illegality if anv.</u>

4. Further this Division's OM (NOC) issued on dated 28th January, 2020 shall be treated as cancelled.
