OFFICE MEMORANDUM

Subject: - REQUEST FOR NOC FOR CONDUCTING RECRUITMENT ON VACANT POSTS (NON-GAZZETTED) IN AIRPORT SECURITY FORCE.

The undersigned is directed to refer to Aviation Division's OM No. 4-25-2015-ASF dated 15<sup>th</sup> June, 2020, on the subject noted above and to state that to obtain a prior NOC from this Division is mandatory before making any kind of recruitment. Moreover, surplus employees with matching qualification, experience and grade are not available in surplus pool for posting against reported vacant posts. Therefore, Aviation Division may fill 611 x vacant uniformed/ civil posts of different cadres ranging from (BPS-01 to BPS-15) i.e. 113 x ASI (BS-11), 459 x Corporal (BPS-7), 15 x Corporal Driver (BPS-05), 01 x Stenotypist (BPS-14), 01 x Draftsman (BPS-11), 02 x UDC (BPS-11), 01 x Tech Assistant (BPS-10), 01 Religious Teacher (BPS-8), 01 x Medical Attendant (BPS-7), 01 x MT Driver (BPS-5), 01 x Cobbler (BPS-02), 02 x Naib Qasid (BPS-01), 09 x Cook (BPS-01) & 04 x Sweeper (BPS-01) in ASF an attached department under that Division as mentioned in the OM under reference in accordance with the approved recruitment rules of the posts subject to completion of all codal formalities and in line with the directions of this Division's Recruitment Policy dated 22-10-2014 as amended from time to time and mechanism dated 16-01-2015, 03-03-2015, 11-5-2017 & 18-8-2017.

2. This NOC is valid for a period of six (06) months from the date of its issuance. However, according to para 1-(xiii) of recruitment policy guidelines dated 22-10-2014, as amended from time to time recruitment is required to be finalized within 120 days from the date of advertisement. Whereas in line with para-1 (xvii) of the policy guidelines, advertisement to be published for recruitment may be submitted by the concerned Ministry/ Division/ Department/Organization direct to press advertisement (PID) for publication.

3. The advertisement to be published for recruitment may be forwarded by the concerned Ministry/Division directly to Press Information Department, Information & Broadcasting Division. However, the appointing authority of the concerned Ministry/Division/Department/Organization shall ensure completion of all procedural and codal requirements in letter & spirit in line with the Recruitment Policy while making recruitment and will be held responsible for illegality if any.
