

Subject: - FILLING OF ALL VACANT POSITIONS LAYING IN THE RECRUITMENT AMBIT OF THE MIN/DIV, ATTACHED DEPTS. LIST ANNEXED. NOTE ANY LEFT-OVER POSITION (S) FROM THE INITIAL LIST OF FALLEN VACANT AFTER THE DATA COLLECTION PROCESS SHALL ALSO BE CONSIDERED.

I am directed to refer to Office of the Controller General of Accounts, Islamabad's' letter.No CGA/Coord/Recruitment/19-20/382 dated 06th March 2020 & No. CGA/Coord/Recruitment/19-20/39 dated 21st August, 2020 on the aforementioned subject and to state that obtaining a prior NOC from this Division is mandatory before making specified kind of recruitment. Moreover, requisite staff with matching qualification, experience and grade is not available in the surplus pool for posting against reported vacant posts. Therefore, Office of the Controller General of Accounts, Islamabad may fill 627x vacant posts (04 x Stenotypist (BPS-14), 01 x Cashier (BPS-12), 15 x Data Entry Operator (BPS-14) 534 x Junior Auditor (BPS-11), 03 x LDC (BPS-09), 04 x Sorter (BPS-03), 04 x Driver (BPS-04), 01 x DR (BPS-04), 47 x Naib Qasid (BPS-01), 09 x Daftri (BPS-01), 05 x Chowkidar (BPS-01) in different offices across the country under CGA an attached department of Finance Division as mentioned in the letter under reference in accordance with the approved recruitment rules subject to completion of all codal formalities in line with the directions of this Division's Recruitment Policy dated 22nd October, 2014 as amended from time to time and mechanism dated 16-01-2015, 03-03-2015, 11-05-2017, 18-8-2017.

2. This NOC is valid for a period of six (06) months from the date of its issuance. However, according to para 1-(xiii) of recruitment policy guidelines dated 22-10-2014, as amended on 21-09-2017 & 04-03-2019 recruitment is required to be finalized **within 120 days** from the date of advertisement.

3. The advertisement to be published for recruitment may be forwarded by the concerned Ministry / Division directly to Press Information Department, Information & Broadcasting Division. However, the appointing authority of the concerned Ministry / Division / Department / Organization shall ensure completion of procedural and codal requirements in letter & spirit in line with the Recruitment Policy while making recruitment and will be held responsible for illegality if any.
