
OFFICE MEMORANDUM

Subject: - EXENTION IN NOC FOR RECRUITMENT AGAINST 124 VACANT POSTS IN BS-1-15 IN ANF.

The undersigned is directed to refer to Ministry of & Narcotics Control's O.M.No.12/2/99-ANF dated 21<sup>st</sup> July, 2020 on the subject noted above and to state that obtaining a prior NOC from this Division is mandatory before making any kind of recruitment. Moreover, requisite staff with matching qualification, experience and grade is not available in the Surplus Pool for absorption against the reported vacant posts. Therefore, M/o of Narcotics Control Islamabad may fill 124 x vacant posts (14 x Sub Inspector (BPS-14), 01 x Sub Inspector Hardware (Tech), (BPS-14), 02 x Stenotypist, (BPS-14), 02 x DEO, (BPS-14), 01 x Photographer), (BPS-13), 02 x UDC, (BPS-11) 10 x ASI Including ASI Finger Print (BPS-11), 01 x Networking Operator / Tech, (BPS-09), 51 x Constable (BPS-07), 22 x Constable Driver (BPS-07), 03 x Constable Operator (BPS-07) 03 x Constable (Dog Attendant) (BPS-07), 05 x Driver (BPS-04), 05 x Naib Qasid (BPS-01), 01 x Cook (BPS-01), 01 x Waiter (BPS-01) In Anti Narcotics Forces under that Ministry as mentioned in the O.M. under reference in accordance with the approved recruitment rules subject to completion of all the codal formalities and in line with the directions of this Division's Recruitment Policy dated 22<sup>nd</sup> October, 2014 as amended from time to time and mechanism dated 16-01-2015, 03-03-2015, 11-05-2017, 18-8-2017.

2. This NOC is valid for a period of six (06) months from the date of its issuance. However, according to para 1-(xiii) of recruitment policy guidelines dated 22-10-2014, as amended as amended from time to time recruitment is required to be finalized **within 120 days** from the date of advertisement. Whereas in line with para-1 (xvii) of the policy guidelines, advertisement to be published for recruitment may be submitted by the concerned Ministry / Division /Department / Organization direct to Press Information Department (PID) for publication.

3. The advertisement to be published for recruitment may be forwarded by the concerned Ministry / Division directly to Press Information Department, Information & Broadcasting Division. However, the appointing authority of the concerned Ministry / Division / Department / Organization shall ensure completion of ll procedural and codal requirements in letter & spirit in line with the Recruitment Policy while making recruitment and will be held responsible for illegality if any
