As per the Prime Minister's directive, issued vide this Division's DO letter No.5/11/2000-T-II/T-1 dated 10-06-2014, this Division's OM No. No.5/11/2000-T-II/T-1 dated 11-07-2019 and OM No. 4/4/2021 dated 15-02-2022, all Ministries/Divisions/ Departments are bound to relieve officers on their selection for training course without fail. The Ministries/Divisions / Departments shall make stop-gap arrangements as the nominated officers are not required to attend their offices while undergoing training. Non-compliance of directions of the Prime Minister, shall result in disciplinary proceedings under Civil Servants (Efficiency & Discipline) Rules, 2020. Moreover, under Rule 8(b) of the Civil Servant Promotion (BS-18 to BS-21) Rules, 2019, a civil servant shall be liable to supersession if he/she fails thrice for any reason to attend the mandatory training.

3. The course fee is Rs. 1,550,000/- per participant. The payment of course fee in respect of officers of occupational groups and ex-cadre officers of all Ministries/Divisions and their attached departments will be made by the Establishment Division while in case of officers of the Provincial Governments and autonomous bodies/organizations etc. nominated for the course shall be arranged by their respective Government/Organization to the President NDU, Islamabad.

4. All selected officers are required to confirm <u>availability by 20.3.2024 along with</u> contact <u>numbers (Office & Cell) and E-mail addresses.</u> In case non-availability, the reason thereof. Further, the officers Sparebility Certificate may also be communicated as per Annex.
