- 2. The course will be commencing from 05-10-2020. The nominated officers may report to NIMs Karachi, Lahore, Peshawar, Islamabad and Quetta on 2<sup>nd</sup> October, 2020. The above nominations are subject to provision of latest Annual Medical Examination Reports to be submitted to respective NIMs.
- 3. The course fee for each participant is Rs. 225,000/, at NIMs, Karachi Lahore, Peshawar and Quetta, except NIM Islamabad having course fee of Rs200,000/-. The payment of course fee in respect of officers of occupational groups and Ex-codre officers of all Ministries/ Divisions and their attached departments will be made by the Establishment Division while in case of officers of the Provincial Governments and autonomous bodies/organizations etc. nominated for the course shall be arranged by their respective departments/governments etc., and to this effect payment shall be remitted to the respective Director General, NIM, through bank grait/cross cheque/pay order at the time of joining the course by the officer concerned or as early as possible.
- 4. As per the Prime Minister's directive, issued vide this Division's DO letter No. 5/11/2000-T-II/T-I dated 10-06-2014 all Ministries/Divisions/ Departments are bound to relieve the officers on their selection for training course without fail. The Ministries/Divisions/ Departments shall make stop-gap arrangements, as the nominated officers are not required to attend their offices while undergoing training. Non-compliance of the directions of the Prime Minister shall tantamount disciplinary proceedings under the Government Servants (E&D) Rules, 1973. Further, according to Rule 8 (b) of the Civil Servants Promotion (BPS-18 to EPS-21) Rules, 2019, if the officer fails thrice for any reason to attend the mandatory training will be recommended for supersession. Therefore, the

officers withdrawn from the subject course under 1 (a) serial no 1 to 4 & 6 above will lose their two chances and one chance and serial no. 5 & 7 to 8 will lose their one chance.
