# Subject: - <u>PRE-QUALIFICATION OF REPAIR/ MAINTENANCE OF MACHINERY/</u> <u>EQUIPMENT, FURNITURE/FIXTURE. IT EQUIPMENT AND</u> HARDWARE/SOFTWARE DURING THE YEAR 2024-25.

The criteria for pre-qualification of Workshops for repair / maintenance of Machinery / Equipment, Furniture Fixture, Building, IT Equipment and Hardware/Software items is as under:

- i) The interested Workshops must have five (05) years' experience in relevant field. The Firms shall provide list of Federal / Provincial Government Ministries / Divisions / Departments to whom, they have provided or providing services.
- ii) The Workshops must have their own complete setup i.e. spare parts availability and technical expertise in Islamabad/ Rawalpindi having Telephone/ Fax facilities etc. in order to provide quality and timely service as per requirement in accordance with all applicable laws, rules and regulations.
- iii) The Workshops must be registered with Sales Tax and Income Tax Department (FBR). Valid documents must be attached.
- iv) The interested parties must have sound financial position; proof may be provided for last three (03) years in shape of income tax and company bank statement.
- v) Conditional, incompleteness and non-compliance to terms and conditions of bidding documents and over writing in bids shall not be accepted.
- vi) Telephonic/faxed/telegraphic/emailed proposals will not be entertained.
- vii) The bidder shall quote the price in Pakistan Rupees (PKR).
- viii) Conditional/operational bid offer will be considered as non-responsive bidder.
- ix) Any bid received after the specified bid submission date and time mentioned in this document shall not be considered and be deemed rejected.
- x) A bid once opened in accordance with the prescribed procedure shall be subject to only those rules, regulations and policies that are in force with at the time of issuance of tender notice by Public Procurement Regulatory Authority (PPRA).
- xi) Interested parties must attach non-black listing certificate on affidavit amounting to Rs.100/- with bidding documents, duly attested by notary public.
- xii) Member(s) of Tender I Purchase Committee may conduct the visit of all Workshops, before the pre-qualification.
- xiii) Bid security amounting to Rs. 100,000/- in favour of DDO, STI, Secretariat Training Institute, Islamabad must be attached with bid in shape of pay order or Bank draft.
- xiv) List of Names and Telephone numbers of their technical teams with their experience shall be attached which may be cross-checked by the Purchase Committee.
- xv) The Firm/Companies/Organizations requiring any further clarification or information of the bidding document may contact the office of Deputy Director (General Services), STI.
