### <u>QUALIFICATION, EXPERIENCE AND</u> AGE LIMITS FOR INITIAL APPOINTMENT

- 4. A candidate must possess the educational qualifications and experience and must be within the age limits as mentioned against the post concerned in the Schedule to this Notification provided that:—
  - (i) "experience" means, experience gained in a regular full-time paid job after obtaining the required qualification;
  - (ii) the period spent by a candidate in obtaining degree of M. Phil or Ph.D in the relevant field shall be treated as practical experience up to maximum period of two and four years respectively for the purpose of initial appointment, provided that:—
