As per the Prime Minister's directive, issued vide this Division's DO letter No.5/11/2000-T-II/T-I dated 10-06-2014, this Division's OM No. No.5/11/2000-T-II/T-I dated 11-07-2019 and OM No. 4/4/2021 dated 15-02-2022, all Ministries/Divisions/Departments are bound to relieve the officers on their selection for training course without fail. The Ministries/ Divisions / Departments shall make stop-gap arrangements, as the nominated officers are not required to attend their offices while undergoing training. Non-compliance of the directions of the Prime Minister shall tantamount disciplinary proceedings under Civil Servants (Efficiency & Discipline) Rules, 2020. Moreover, according to Rule 8(b) of the Civil Servant Promotion (BS-18 to BS-21) Rules, 2019, a civil servant shall be liable to supersession subject to the provisions of Rule 22 ibid, if he/she fails thrice for any reason to attend the mandatory training. Further, the officers Sparability Certificate may be communicated as per **Annex-I**.

3. All selected officers are required to **be vaccinated** and report to National Defence University (NDU) at 10:00 hours on 12-08-2023 for familiarization visit / briefing. 
