
2. The course has commenced from 24-10-2022. The officers, must be vaccinated against Covid-19, are required to report **immediately**. The above nominations are subject to provision of latest Annual Medical Examination Reports to be submitted to NSPP. For further queries Mr. Rana Akbar Ali (0321-4088255) Coordinator, NSPP may be contacted.

3. It is informed that **Rule 8(b)** of the Civil Servants Promotion (BS-18 to BS-21) Rules, 2019; provides that a civil servant shall be liable to supersession subject to the provisions of Rule 22 *ibid*, if he/she **fails thrice** for any reason to attend the mandatory training. Therefore, in the event of nomination of officers for the training, in terms of this Division's O.M No. 4/4/2021-T-I dated 15-02-2022, the controlling Ministries / Divisions / Departments/ Government are bound to relieve the officers on their selection for training course without fail as per the Prime Minister's directive, issued vide this Division's D.O letter No. 5/11/2000-T-II/T-I dated 10-06-2014, the Ministries/ Divisions / Departments shall make stopgap arrangements, as the nominated officers are not required to attend their offices while undergoing training, hence requisite arrangements be

made for their separability. Non-compliance of the directions of the Prime Minister can attract disciplinary proceedings under the Government Servants (E&D) Rules, 2020/Provincial Rules.

4. In view of foregoing, upon withdrawal of the officers vide para 1-A(1) (2) & (3) from the subject course their first chance would be counted whereas upon re-nomination of officer at Sr. No. 1-B(1) his three chances will remain intact in terms Rule 8(b) of the Civil Servants Promotion (BS-18 to BS-21) Rules, 2019.


5. The course will be fully residential. The course fee is Rs. 1,000,000/- per participant which covers the boarding and lodging expenses at the respective NSPP centers including expenses on mandatory inland study tour (the case for an increase in the course fee up to 1,800,000/- per participant is under process upon request of NSPP). The payment of course fee in respect of officers of occupational groups and Ex-cadre officers of all Ministries/Divisions and their attached departments will be paid by the Establishment Division while in case of officers of the Provincial Governments and Autonomous Bodies/Organizations etc. nominated for the course, it shall be arranged by their respective Ministries/Divisions/Provincial Governments/Autonomous Bodies/Corporations through Bank draft/cross cheque/pay order at the time of joining the course by the officer concerned or as early as possible.
