- i. At least three (03) years of experience in such coaching having promising success ratio of qualified and allocated candidates from above mentioned areas/quotas;
- ii. Having experienced and qualified subject specialists as faculty (list be provided);
- iii. Having competitive fee structure alongwith highlighting the duration of such course;
- iv. Having sufficient capacity in terms of covering largest possible geographical areas to outreach and impart coaching to candidates in above mentioned areas/quotas;
- v. Having the capacity to simultaneously impart coaching to at least one thousand candidates;
- vi. Having sufficient modes of coaching i.e. physical classes, online coaching and arrangement of seminars during the course timeline through outreach programme to cover maximum number of candidates from above mentioned areas/quotas;
