TERMS & CONDITIONS/INSTRUCTIONS

- 1. Sealed tenders in one stage two separate envelops; one for financial and other for technical comparison of PPRA Rules 2004 36(b), are invited from reputable firms for provision/supply of catering service for canteen/cafeteria located at Establishment Division, Cabinet Block, Islamabad during working days; containing:
 - i. Proposed menu with rates for breakfast, lunch and refreshments.
 - ii. List of trained staff strength (Cooks, Tandorchi, waiters/serving staff)
 - iii. Specific experience of cooking & serving with certificates from government / reputable private / public organizations.
 - iv. Complete Set of Documents as per requirements mentioned in Annex-I (Technical Qualification Criteria)
- 2. Bidding firm / company must submit documentary evidence (Bank statements of last 2 years) showing their sound financial position and reputation.
- A company / firm (vendor) which is on Active Taxpayers List (ATL) qualifies to participate in the bidding process. Copies of NTN and STN certificates must be submitted along with the bids.
- 4. Incomplete bids or bids which do not meet the criteria laid down in (Annex-I) and other terms and conditions will be rejected.
- 5. Sample of the high ceramic crockery to be used for serving (plates, cups, glasses etc) will be examined by the Establishment Division in advance and the samples of all crockery items must be submitted at the time of bid opening.
- Medical Fitness Certificate of the Canteen staff, food handlers has to be provided by the successful Bidder.
- 7. There should be standardized and satisfactory cleanliness and hygienic measures including uniforms for staff. Staff and workers of the canteen should wear neat & clean uniform. The color and style / design of uniform shall be approved in coordination with the Establishment Division.
- 8. Furniture and other electrical appliances (Air Conditioners, Fans) have to be arranged by the Contractor/Vendor.
- 9. In case of approved tender, successful contractors will sign the contract on Stamp Paper of value Rs. 100/- or more certified by the Notary Public/Oath Commissioner.
- 10. The contractor shall not appoint sub-contractor to carry out the contractual obligation in the canteen. The contract of a Successful bidder or contractor if found to have sublet the canteens to someone else will be terminated. This termination may also include blacklisting of the contractor / firm.
- 11. Quality of food items should have to be as per the Government standards prescribed by Pakistan Food Authority. If any complaint received from any officer / official, the Establishment Division has the right to terminate the contract.

- 12. The Contractors will be required to submit Bank Draft / Pay Order (Refundable) Rs. 25,000/- each canteen in favor of Establishment Division, Islamabad for Canteen as security deposit with their quotations. No quotation will be accepted without security deposits.
- 13. The list of food items shall be approved by the Establishment Division and must always be displayed on a notice Board in Cafeterias.
- 14. The successful Contractor / company shall occupy the allocated space on 'as is where is basis' and shall install minimum Furniture & Fixtures electrical appliances (Air conditioners, Refrigerators, vending machines & lights).
- 15. The first three months of the renewable contract will be considered as probationary period to evaluate the quality of food & services rendered. The term of the contract shall be 03 years subject to revalidation of Establishment Division on annual basis.
- 16. The successful Contractor / company will keep the premises clean at its own expense, including the minor day-to-day repairs and maintenance of appliances. The successful Contractor / company will not carry out any alterations or renovations or renovations within the allocated space without prior approval of the Establishment Division.
- 17. The successful Contractor / company will be solely responsible for all disciplinary matters of its employees, agents or representative and remain liable for all damages or losses if any suffered by the Establishment Division or third parties due to the negligence and / or misconduct of his / her employees, agents or representatives.
- 18. The personnel should be security cleared and security passes be issued by DSP Security, Cabinet Division.
- 19. Firm have to pay a flat rent of Rs. 30,000/- per month including rent and utility charges.
- 20. Black listed firms/companies need not apply.
- 21. The Establishment Division authorities reserve the right to accept or reject the tenders as per PPRA Rules.

Bidder's Eligibility:

Eligible parties / contractors shall be evaluated as per Pre-Qualification / Eligibility criteria as given in **Annex-I**.

Bidder's Evaluation Criteria:

The Establishment Division will consider only the top candidates with highest scores in Pre-qualification / evaluation criteria for onsite inspection and evaluation of quality of their services and Food at currently ongoing projects of the Bidders. For this purpose, the representatives from Establishment Division will inspect the canteen / restaurant of the Bidder and rate the top bidders in order of quality of service and food.

Bidding Awarding Formula

The bid will be awarded to the most advantageous bidder as per below formula:

- i. Technical qualification passing marks will be 60%.
- ii. 70% weightage will be given to technical proposal and 30% to financial proposal.
